## WIRELESS TELECOMMUNICATIONS BUREAU ANNOUNCES AGENDA AND SPEAKERS FOR PUBLIC FORUM FOR THE 7<sup>TH</sup> ANNUAL COMMERCIAL MOBILE RADIO SERVICES COMPETITION REPORT

Released: February 25, 2002

As previously announced by a Public Notice released on February 14, 2002,<sup>1</sup> the Wireless Telecommunications Bureau will hold a Public Forum addressing issues related to the acquisition and analysis of data on the state of competition in the Commercial Mobile Radio Services (CMRS) industry for the Federal Communications Commission's 7<sup>th</sup> Annual CMRS Competition Report. The Public Forum will be held on February 28, 2002 from 1:00 p.m. to 5:00 p.m. at the Federal Communications Commission, 445 12<sup>th</sup> Street, SW, Washington, DC, in the Commission Meeting Room. The Public Forum will be open to the public and seating will be available on a first come, first served basis.

The Public Forum will focus largely on data regarding the development of rural and underserved wireless markets. Specifically, the Public Forum will address ways in which the Commission can acquire and analyze industry data and levels of competition in such markets.
