ERRATUM

By the Chief, Auctions and Industry Analysis Division:

This erratum makes minor corrections to the final rules contained in the Appendix of the *Order*, DA 02-847, released on April 11, 2002. A summary of the *Order* has not yet been published in the Federal Register. Accordingly, the corrections set forth below will be incorporated in the summary of the *Order* published in the Federal Register.

1. In the Appendix of the *Order*, sections 24.711 and 24.716 are modified by replacing all references to “section 1.2110(n)” with “section 1.2110(o)”.
2. In the Appendix of the *Order*, the amendatory language to section 90.1103 is modified to read as follows: “Amend § 90.1103 by removing paragraphs (b)(3), (b)(4), and (c), redesignating paragraphs (b)(5) and (d) as paragraphs (b)(3) and (c), and revising newly redesignated paragraph (c) to read as follows:”.
3. In the Appendix of the *Order*, the amendatory language to section 95.816 is modified to read as follows: “Amend § 95.816 by removing paragraphs (c)(3), (c)(4), and (d), redesignating paragraphs (c)(5), (e), and (f) as paragraphs (c)(3), (d), and (e), revising paragraph (a) and newly redesignated paragraphs (d) and (e) to read as follows:”.
4. In the Appendix of the *Order*, the amendatory language to section 95.823 is modified to read as follows: “Amend § 95.823 by removing paragraph (c)(1), redesignating paragraphs (c)(2) and (c)(3) as paragraphs (c)(1) and (c)(2), and revising newly redesignated paragraph (c)(1)(iii) to read as follows:”.

5. In the Appendix of the *Order*, the amendatory language to section 101.538 is modified to read as follows: “Amend § 101.538 by removing paragraphs (a)(5), (a)(6), (a)(8), and (b), redesignating paragraphs (a)(7) and (c) as paragraphs (a)(5) and (b), and revising newly redesignated paragraphs (a)(5) and (b) to read as follows:”.
6. In the Appendix of the *Order*, the amendatory language to section 101.1209 is modified to read as follows: “Amend § 101.1209 by removing paragraph (b)(2), (c), (d), and (e), redesignating paragraph (b)(3) as (b)(2), and revising newly redesignated paragraph (b)(2) to read as follows:”.
