Methodology for Functionality Levels

AMTA offers HAC compatible handsets and devices in all major price categories, including low-cost and features (C Level, generally less than \$100); moderate cost and features (B Level, generally \$100-\$250); and high-end, feature

rich (A Level, generally greater than \$250). Costs generally correlate with the number of features, but, if through experience, AMTA finds that a certain handset contains features that work well with hearing aids, such as volume control, it will be labeled accordingly at the high-end, feature rich or A Level for functionality. AMTA's sales staff is trained to assist all existing and prospective customers looking for a HAC-complaint device or handset. HAC compatible handsets and devices vary in their inherent levels of functionality, but typically at least one HAC-compliant handset or device with features and services typical of its price category can be found that meets each customer's price range.
