Compliant models are listed on the company web site, and retail sales personnel are trained to assist with compliant digital wireless phones. Compliant handsets are available for testing in retail locations. Written materials and promotional literature are provided at the point of sale and on the website, addressing the needs of individuals with hearing disabilities. Such consumers are given a 30-day trial period within which to try out digital wireless phones to determine whether they will work properly with their hearing aids.

Methodology for Functionality Levels

Pine Cellular offers a variety of HAC phone models to meet the needs of wireless users with hearing disabilities. Models are presented by category of price

ADVANCED handsets are \$225 or more and generally offers enhanced features such as higher quality camera, Bluetooth, video capabilities, internet access, high-speed processing, touch or tilt screen, and email.

AVERAGE handsets are \$125 to \$224 and generally offer lower-quality camera compared to advanced models, Bluetooth, internet access, increased memory capabilities, larger phonebook capacity, enhanced color display and increased talk time over basic models. However, these may be older, less stylish phones.

BASIC handsets are less than \$125, offer the necessary wireless features, and may have lower quality camera, Bluetooth or internet capabilities. Typically these offer smaller phonebook capacity and average talk time. Most of these models are generally larger in size compared to more advanced models and lack features such as MP3 players, expandable memory and download capabilities
