Compliant handsets are available for testing from live phone displays in retail locations. Written materials, pamphlets and other promotional literature are provided at the point of sale and on the website, addressing the needs of individuals with hearing disabilities. Consumers are given a 30-day trial period within which to try out digital wireless phones to determine whether they will work properly with their hearing aids.

Methodology for Functionality Levels

Level 1 Phones are less than \$199 and offer basic wireless telephone features, may not have a camera, Bluetooth, or Internet access capability, and generally lack such features MP3 players and expandable memory.

Level 2 Phones are \$200 to \$299 and may have a camera, Bluetooth, or Internet access capability, but usually do not come with a full suite of features.

Level 3 Phones are \$300 to \$399 and have features for business users, including Bluetooth, Internet access capability, increased RAM storage enhanced color display, and camera.

Level 4 Phones are \$400 and above and generally have advanced features such as expandable memory, enhanced camera, Bluetooth, video, Internet access capability, touch screen, faster processing, email and Windows Office Mobile.
