Consumer Outreach

Describe consumer outreach efforts in the past 12 months: T-Mobile makes information available to consumers about the availability of its current HAC product offerings. T-Mobile's HAC compliant handset boxes are labeled. In addition, T-Mobile places the HAC M-rating, and where required, T-rating information on its price/feature cards, which are located in T-Mobile owned and operated retail stores. HAC product information is available on T-Mobile's public webpage, which is referenced within this Status Report.

T-Mobile embraces opportunities to talk about its HAC offerings, as well as other products, services and innovations designed to promote accessibility, to broad audiences by participating in conferences and seminars attended by organizations representing persons with hearing loss and members of such organizations. As an example, during June 2013, T-Mobile exhibited and participated at the Hearing Loss Association of America's annual national convention in Portland, Oregon and at the M-Enabling Conference held in Arlington, Virginia. In addition, T-Mobile participated in an accessibility roundtable at the May 2013 CTIA Show in Las Vegas, Nevada and served as a panelist at the State of the Science Conference on Accessible Telecommunications hosted by Gallaudet University in September 2013. In many of the discussions that take place at these gatherings, T-Mobile continues to stress the importance for consumers to try/test HAC handsets prior to purchase. Furthermore, T-Mobile offers a voice-barred/data-only plan for certain devices, which is attractive to customers with profound hearing loss.

Methodology for Functionality Levels

Good Category

HAC devices in the Good category cover the range from basic bar devices to core feature handsets. Although many of these handsets are quad-band that operate over four GSM frequency bands (1900 MHz, 1800 MHz, 900 MHz, 850 MHz), some HAC devices that fall within this category operate over fewer than these four frequency bands and we note some even operate at WCDMA bands (850 MHz, 1700 MHz, 2100 MHz) and are capable of Wi-Fi calling.

Best/Premium Category

HAC devices categorized in the Best/Premium category include quad-band GSM/WCDMA devices, all of which are high-speed enabled. These devices feature higher-end design, material and finish, paired-up with a more sophisticated user interface and functionality. Typically, such devices contain advanced features and applications.

Report Remarks

Form 655 does not allow the filer to add remarks to yes or N/A answers to the Labeling questions. With respect to the third question, T-Mobile provides information when the manufacturer notifies it. With respect to the fourth question, T-Mobile did not offer VoLTE service in 2013.

The Commission has indicated that the service providers are expected to verify handset model-specific HAC information: from the manufacturer's previous reports to the Commission, from the manufacturer's own website, or from the manufacturer directly. See Amendment of the Commission's Rules Governing Hearing Aid-Compatible Mobile Handsets; Petition of American National Standards Institute; Accredited Standards Committee C63 (EMC) ANSI ASC C63, First Report and Order, 23 FCC Rcd 3406, 3445-56 para 98 (2008) (2008 Order). Additionally, the FCC has indicated that the service providers also should check the FCC's equipment authorization search website. In preparing its HAC Report covering 2013, T-Mobile encountered instances where for certain handsets there were differences between the HAC rating or frequency information on the FCC's equipment authorization search website and the information reflected in the confirming documentation T-Mobile received from the OEM/manufacturer (upon which T-Mobile is allowed to rely) and/or from the manufacturer's previous reports to the Commission. As part of its due diligence efforts, T-Mobile investigated such discrepancies and where significant has included an explanation in the Remarks sections for applicable handsets.

The T-Mobile/MetroPCS merger was consummated on May 1, 2013. Some of the devices listed within this Status Report as part of T-Mobile's portfolio were part of the MetroPCS portfolio, then operating as a separate entity during January 1 - April 30, 2013 of the reporting period - a time during which T-Mobile did not have control. As a result, certain device information reflected in this Report, such as offering dates, is based on representations made by former MetroPCS personnel.
