You are encouraged to [register with the Commission](#) as soon as you expect to do business with the FCC. This way, you will be ready to access any of the electronic licensing systems without having to go through the registration process at the time you submit an application.

The Wireless Telecommunications Bureau began requiring the FRN for the Universal Licensing System and Antenna Structure Registration on December 3, 2001.
