ANNOUNCING THE FINAL STATUS OF APPLICATIONS RECEIVED
FOR THE 10 NATIONWIDE NARROWBAND
PERSONAL COMMUNICATION SERVICE (PCS) LICENSES
TO BE AUCTIONED BEGINNING JULY 25, 1994 AT THE
OMNI SHOREHAM HOTEL, WASHINGTON, DC

The Federal Communications Commission (FCC) has found 29 applications to be acceptable for filing and thus able to participate in the Narrowband Personal Communication Service (PCS) license auction beginning July 25, 1994 at the Omni Shoreham Hotel in Washington, D.C.

All applications which were received have been reviewed for completeness and compliance with the Commission's rules and have been classified into two categories: A) ACCEPTABLE FOR FILING; and B) UNACCEPTABLE FOR FILING. Each of these categories has been sorted and is presented in one or two formats: one lists the applications alphabetically by name of the applicant and the other sorts the markets numerically, with each applicant for that specific market listed alphabetically. Those applications which were unacceptable for filing either requested withdrawal or were defective for one or more reasons; however, each such application failed to submit the upfront payment required.

Unless otherwise directed by the FCC, those applications which are ACCEPTABLE FOR FILING need take no further action with respect to their applications before auction day except to keep their applications up to date. See Section 1.65 of the Rules. These applications are identified in Attachment A to this Public Notice and are available for viewing in the Commission's Cellular Radio Reference Room, Room 628, 1919 M Street, N.W., Washington, D.C. 20554.

Successful short form applicants are invited to attend a practice electronic bidding session to be held from 4 - 6 P.M. on Sunday, July 24, 1994 and again on Monday, July 25 from 8 - 9:30 A.M. in the Blue Room of the Omni Shoreham Hotel at 2500 Calvert Street, N.W. in Washington, D.C.

Those applications in the UNACCEPTABLE FOR FILING category are identified in Attachment B. These applicants are ineligible to participate in the auction.
