28 APPLICANTS QUALIFY TO BID ON THE 30 REGIONAL NARROWBAND PERSONAL COMMUNICATION SERVICE (PCS) LICENSES

28 applicants qualified to bid in the regional narrowband Personal Communications Service ("PCS") auction beginning on October 26, 1994 at the Postal Square Building, located at 2 Massachusetts Avenue, N.E., Washington, D.C. Together these applicants submitted upfront payments in excess of \$13 million.

All applications which were received have been reviewed for completeness and compliance with the Commission's rules. Only those applicants whose applications have been designated **ACCEPTABLE FOR FILING** and who have submitted a timely upfront payment sufficient to establish bidding eligibility are designated as qualified applicants and will be allowed to participate in the regional narrowband PCS auction. All qualified applicants are listed on Attachment A to this Public Notice.

Each of these applications has been sorted and is presented in two formats: one lists the applications alphabetically by name of the applicant and the other sorts the markets numerically, with each applicant for that specific market listed alphabetically.

Unless otherwise directed by the FCC, those applications which are **ACCEPTABLE FOR FILING** need take no further action with respect to their applications before the auction except to keep their applications up to date. See Section 1.65, 47 C.F.R., Part 1 of the FCC Rules. These applicants are identified in Attachment A to this Public Notice and are available for viewing in the Commission's Cellular Radio Reference Room, Room 628, 1919 M Street, N.W., Washington, D.C. 20554.
