### Report Remarks

Although several of the handsets available to customers from the Company via iWireless's website are capable of operating on the WCDMA air interface, the Company only operated on the GSM air interface in the reporting year. The Company did not offer service using the WCDMA air interface in the applicable time period. The HAC handset benchmarks set forth in Section 2019(c)(3) apply only for each interface actually offered by a carrier, and the HAC handset requirements for a particular interface are triggered only after a service provider has actually started providing service using that air interface. Hearing Aid-Compatible Telephones (Petitions for Waiver of Section 20.19 of the Commission's Rules), Memorandum Opinion and Order, 22 FCC Rcd 7171, para. 60 (2007). Accordingly, the HAC handset requirements with regard to the WCDMA air interface are inapplicable to the Company.
