Consumer Outreach

Describe consumer outreach efforts in the past 12 months: Mid-Rivers Wireless hearing aid compatibility information sheet is available at each retail outlet and is reviewed regularly to ensure continuing accuracy. Mid-Rivers continues the practice of including HAC information in customer invoices periodically, and maintains signs in each retail location encouraging customers and prospective customers to ask a sales representative about HAC issues. Information regarding hearing aid compatibility is also available on the Company's web site.

Methodology for Functionality Levels

Mid-Rivers Wireless assigns each compliant handset a level of functionality based upon the company's assessment of two factors: price and operating features. Lower priced handsets with fundamental capabilities are defined as "Basic". More advanced functions or functionality with the availability of Wireless Internet or Wi-Fi capability or an operation system that supports advanced applications are classified as "Intermediate". More expensive phones with 4G capability (higher bandwidth and lower latency supporting more advanced operations such as video streaming) are classified as "Advanced". Mid-Rivers Wireless attempts to maintain a full selection of compliant handsets across all levels of functionality but may, from time to time, be unable to meet that goal due to limitations in the availability of handsets from suppliers.

Report Remarks

On December 31, 2014, Cable & Communications Corporation (FRN 0001634443) was reorganized as a new entity, Cable & Cellular Communications, LLC ("C&CC"), a single-member Montana limited liability company. The reorganization did not affect C&CC's ownership -- it remains a wholly-owned subsidiary of Mid-Rivers Telephone Cooperative, Inc.

This is the final HAC report that will be filed under FRN 0001634443. The new entity, C&CC, operates as a successor entity under a new FRN: 0024205064. All subsequent HAC reports will be filed under this new FRN.
